- 1. 621 & 622 are a two-course sequence that should be taken in back to back semesters
- 2. 631/651/642 can be moved between fall semesters as students wish; however, students interested in the Public Financial Management certificate must take 631 no later than their second fall. 642 can be taken any fall, though students interested in pursuing the Non-Profit Management certificate may wish to take it in the first or second fall to determine whether such a certificate would be right for them. No other courses (except areas of concentration) should be moved to a different semester without consultation with the Graduate Coordinator and DGS and all courses are generally offered only in the fall or only in the spring.
- 3. 623 & 681 are a two-course sequence designed to culminate in a capstone. 623 is offered only in the fall. 623 & 681 may not be taken in the same semester and 681 must be taken in a student's last semester. If a student wishes to speed up or slow down their part-time degree and wishes to graduate in the summer or fall, please reach out to the Graduate Coordinator and DGS as soon as possible for guidance.
- 4. Area of concentration courses are electives and can be moved to the semesters that work best. We encourage students to select them carefully to build additional expertise in an area. Students can find approved electives by viewing their degree audit; other electives can be approved on a case-by-case basis by the DGS. Students may take electives to simultaneously acquire a Public Financial Management or Non-Profit Management certificate (must apply for certificates; please reach out to the Graduate Coordinator if interested).
- 5. Students with a traditional internship should take PA 711 in their last fall after their internship is complete. Students who will do a project to fulfill PA 711 because they have extensive, relevant work experience should take PA 711 in their penultimate spring semester. Those with extensive, relevant work experience may also request a waiver for PA 711; in this case, they will need to take an extra elective in its place.
- 6. 691 is an online synchronous course taken simultaneously by both online and in-person MPA students. Occasionally, other core courses are offered only online and a few electives are online only.
- 7. As a rule, in-person students are required to take in-person courses when offered unless they have permission of the DGS to do otherwise. Online students are required to take online courses.
